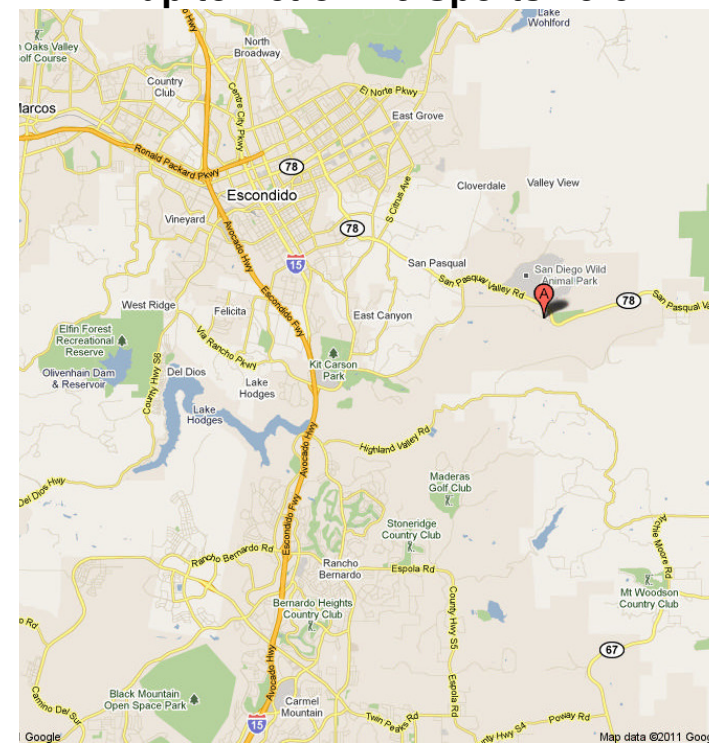

SPECIAL NOTE:

There are no pre-requisites for entering any class; however, once a dog has earned a qualifying score in a higher class, it is ineligible to enter a lower class.

Bitches in season shall be eligible and will run at the end of the class in tests and in catalog order as listed in the class in trials.

ENTRY INFORMATION

An owner may enter a dog in any trial class he or she deems appropriate. However, once that dog has acquired a qualifying score in an upper class at a licensed or member trial, it shall be ineligible for entry in any lower class.

Entries must be on the enclosed entry blank or a reasonable facsimile thereof. Photocopies must include the Agreement on the back of the entry form.

Entries must be received at the Trial Secretary's address by the published closing date to be acceptable. Returned Checks do not constitute a valid entry fee. No entry shall be made and no entry shall be accepted which specifies any condition as to its acceptance.

Entries must be on the enclosed entry blank or a reasonable facsimile thereof. Photocopies must include the Agreement on the back of the entry form.

Dogs must be ready for their classes. Test/Trial judges have the authority to refuse to judge any dog which does not appear within five minutes of being called for its run. The Test/Trial-giving Club and the Event Secretary have no obligation or responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

The Herding Secretary shall notify all entrants of their position on the alternates list at the time the test/trial program is mailed to each entrant. Those alternates that do not run or do not have the opportunity to run shall have their entry fees returned.

The alternates list shall be used to fill vacancies that occur in the drawn running order, with the first available alternate entry replacing the first vacancy in the class entered.

ENTRANTS ON THE ALTERNATES LIST MUST CHECK IN WITH THE TRIAL SECRETARY ON THE GROUNDS NO LATER THAN 30 MINUTES BEFORE THE COMMENCEMENT OF THEIR CLASS.

The club may decline any entries for cause and may refuse to receive or may remove any dog on account of disease, viciousness or other causes, and no one shall have any claim or recourse against the club or any official thereof.

Exhibitors must be governed by any rules or regulations of civil authority, building and parking restrictions. Vehicles parked contrary to regulations will be subject to towing at the owner's expense.

All dogs present must be held on leash or otherwise restricted except when working stock. Under NO circumstance will dogs be allowed to disturb the testing stock or interfere outside the arena with another dog's performance in the arena. Any dogs aggressive to persons or stock will be removed.

NO LOOSE DOGS!

ELIGIBILITY

All dogs nine months of age or older that are registered with the American Kennel Club and classified as Herding Dogs under Chapter 2 of the Dog Show Rules are eligible to participate in herding tests and trials. Dogs classified as Herding Dogs under Chapter 2 of the Dog Show Rules that have been granted an Indefinite Listing Privilege (ILP) or Purebred Alternative Listing (PAL) may participate in tests and trials.

No dog may be entered in two classes on the same course with the same kind of stock under the same judge at any test/trial.

Bitches in season shall be eligible and will run at the end of the class in tests, and in catalog order as listed in the class in trials.

A dog must be entered in the name of the person who actually owned it at the time entries for the herding test or trial closed. If a registered dog has been acquired by a new owner, it must be entered in the name of its new owner in any herding test or Trial for which entries closed after the date of acquisition. Regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his or her name. State on entry form whether transfer application has been mailed to AKC. (for complete rule refer to Chap. 14, Sect 3 of "Rules Applying to Registration and Dog Shows")

AGREEMENT

I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting there from, sustained by any person or persons, including myself (ourselves) or on account of damage to property, arising out of or in consequence of my (our) participation in the Herding Test or Trial, howsoever such injuries, death or damage to property may be caused, and whether or not the same may have been caused or may be alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other persons.

I (we) will pay for any livestock injuries or replacement value in the event of death of any livestock by my (our) dog. In case of any injury to any stock caused by the dog entered, I (we) will assume total responsibility for any damage I (we) agree to pay the full market value of the injured animal in case of serious injury, or the veterinarian bill if the injury is slight.
